MOST GRANTS ARE MULTIPLE YEAR AWARDS, AND TREE FUND IS ACTIVELY ENGAGED IN MANAGING THEM FROM INCEPTION TO COMPLETION AND DISSEMINATION OF FINAL REPORTS.
